Calvert NJROTC Polar Plunge Waiver

I fully understand that the Calvert NJROTC Long Beach Polar Plunge involves risk of serious bodily injury, including permanent disability, paralysis and death, which may be cause by my own actions or inactions, those of other participating in the event, the conditions in which the event takes place, or the negligence of the "releases" named below; and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I and/or my minor child incur as a result of my and/or my minor child's participation in the Activity.

I hereby release, discharge and covenant not to sue Calvert County Public Schools, Calvert High School NJROTC and Long Beach Association, event sponsors, sites, respective administrations, volunteers, other participants and if application, owners and lessors of premises on which the Activity takes place (each considered one of the "releases" herein), from all liability, claims, demands, losses or damages on my account and/or that of my minor child cause or alleged to caused in whole or in part by the negligence of the "releases" or otherwise, including negligent rescue operations; and I further agree that if, despite the release, waiver of liability, and assumption of risk, I, or anyone on my/and or my minor child's behalf makes a claim against any of the "releases", I will indemnify, save and hold harmless each of the releases from any loss, liability, damage or cost which any may incur as the result of such claim.

I have read this agreement, fully understand its terms, understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intent it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect.
